- a. Anderson moved to approve bills and payroll in the amount of \$23,083.50, supported by Taylor. All ayes, motion carried.
- Motion was made by Dietrich to approve August 11<sup>th</sup>, 2021, Regular Board Meeting Minutes.

#### 4. REPORTS

a. Under reports the Board had invited Becky Huttenga from Ottawa County Planning and Performance Improvement to discuss broadband. She was invited to help the Board, and residents understand what we can do regarding the terrible internet service Wright Township, and some surrounding areas have. There were a lot of questions and answers, but it came down to the best thing we can do right now is to fill out the Broadband Survey offered by the County. - b. Resolution 21-09-07 to change Township sewer REU's to correct numbers. Dietrich motioned and Frank supported to approve Resolution 12-09-07. Roll call was taken: Dietrich, aye-Anderson, aye Taylor, aye Schoenborn, aye Frank, aye. Motion carried.
- c. Berlin Race Track. Jeff, and Nick from the Track requested permission from the Board to schedule events in October 2021. Dietrich motioned to approve the Berlin Race Track to schedule events in October 2021, and Anderson supported. Motion carried.

#### 8. SUPERVISOR REPORT

a. Supervisor reported on a new Ordinance being considered called the International Property Maintenance code, or IPMC. Not having enough information, we will have it on the agenda next month.

## 9. BOARD COMMENTS

- a. Frank shared that after Consumers Energy came and went through the building to see how we use electricity; they made a report on our usage. What they offered was quite pricey, and would take several years to recuperate the cost back. It did not look like a good thing to do. Anderson offered to have an electrician look at the report for a second opinion.
