- b. Discussion of Fire Millage wording has been tabled until the board can get the wording from the County. The Board will have a special board meeting for this.
- c. Bids for boiler and the new web site have been tabled until next board meeting, more information is needed. Anderson motioned to accept the bid for the three trees next to the township building from Lance's Climbing Service. Supported by Frank, all ayes, motion carried.
- d. Frank motioned to approve the PA-116 for Sam Armock. Anderson supported, all ayes, motion carried.

- e. Frank motioned to approve firework permit for Berlin Raceway. Taylor supported, all ayes, motion carried. Firework dates are 05/28/22, 07/02/2022, 08/06/22 and 09/03/22.
- 11. Schoenborn reported that on April 21, 2022, at 1:00 p.m. there is a meeting on rural broadband. The Governor has allocated a large amount of money to be used for this. Ottawa County has collected a lot of data, though surveys, on this subject, and this meeting is to update us on what is going to be done to get broadband in rural areas. Frank and Dietrich will attend the meeting.
- 10. Under board comments Frank wanted to thank the Fire Department for all the help given to the board to set up and take down the Township Town Hall Meeting. They went above and beyond.
