

**WRIGHT TOWNSHIP
REGULAR BOARD MEETING
MINUTES
SEPTEMBER 14TH, 2022 – 7:30 PM

1. Meeting was called to order at 7:30 P.M. by Supervisor Rick Schoenborn with the pledge of allegiance and a prayer. Board members present at the meeting: Supervisor Rick Schoenborn, Clerk Theresa Frank, Trustee Brad Anderson, Treasurer Sharyl Dietrich, and Trustee Adam Taylor.
2. Frank motioned to approve the agenda with the addition of 6a., re-approve ordinance, 7d., discuss Lakeshore Advantage. Dietrich supported. All ayes, motion carried.
3.
 - a. Anderson motioned, and Frank supported to approve bills and payroll in the amount of \$38,801.52, and accept as information the Treasurer's Report as written. All ayes, motion carried.
 - b. Dietrich motioned to approve minutes from August 10, 2022, Regular Board Meeting. Taylor supported. All ayes, motion carried.
4. Public Comments;
 - a. Mr. Arnold Grover, from Grover Real Estate, was at the meeting to speak about a two-acre piece of property connected to the 80 acres the Township recently acquired. He spoke a little about the pricing and the easement on the property. He pointed out that he was not looking for comment, but he just wanted us aware this property is for sale. No comment was given, and the Board thanked Mr. Grover for coming to the meeting.
5. Reports;
 - a. Fire report was given by Fire Board Member Adam Taylor. He reported there were 91 calls in August. Also 3 members started medical first responders training last week. The Fire Board currently has 3 applications on file, and they plan to interview soon.
 - b. Dietrich gave the Senior Service report. Reporting free lunch next week, and a few bus trips planned. A news letter was sent out with details.
6. Unfinished business;
 - a. Ordinance 2022-06-01, a Zoning Map Amendment, needs to be re-approved, because it did not hit the right dates for publication. Frank motioned to approve Ordinance Amendment 2022-06-01, and was supported by Dietrich. Roll call was taken; Dietrich, aye – Taylor, aye – Anderson, aye – Schoenborn, aye – Frank aye. Ordinance Amendment has been declared adopted.
7. Under New Business
 - a. Anderson motioned to adopt Wright Township Resolution 2022-09-01, to establish a Property Advisory Committee. Frank supported. Roll call was taken; Schoenborn, aye – Taylor, aye – Anderson, aye - Dietrich, aye – Frank, aye. Resolution has been declared adopted.
 - b. Anderson motioned to approve reorganization of Township policies. Dietrich supported. Motion carried.
 - c. Discussion was had regarding the Audit Booklet with all the Audit information.
 - d. The Township normally contributes to Lakeshore Advantage, an economic development agency for the Township's businesses to use. This year we are going to get more information on how much the Township actually used them. Frank has offered to contact them to get more detail and bring it to

next month's meeting for discussion.

8. Supervisor's Report;
 - a. Under Supervisor reports Dietrich motioned to use VanKempen Electric for the lighting needs in Veteran's Park for \$4,500.00. Frank supported, and motion was carried.
9. Board Comments
 - a. Taylor brought up the subject of Solar Gardens and wanted to know what we have in our ordinances regarding Solar. Anderson offered to bring this up at the next Planning Commission meeting and bring information to the next meeting.
 - b. Frank reported that she is going to purchase cameras for Election security with grant dollars.
10. Supervisor adjourned the meeting at 8:21 p.m.
