PLEASE TAKE NOTICE that any qualified elector of the County of Ottawa, Michigan, who is not already registered, may register to vote at the office of their city or township clerk; the office of the County Clerk; a Secretary of State branch office, or other designated state agency. Registration forms can be obtained at mi.gov/vote and mailed to their city or township clerk. Voters who are already registered may update their registration at www.expressSOS.com.

The last day to register in any manner other than in-person with the local clerk is:
Monday, February 12, 2024

NOTE: After this date, anyone who qualifies as an elector may register to vote in person with proof of residency (MCL 168.492) at their local clerk's office at the above posted dates and times.

All city or township clerks' offices will be open
from 7 am to 8 pm on Election Day, Tuesday, February 27, 2024 for the purpose of registering voters.

QUALIFICATIONS TO REGISTER TO VOTE:

- Citizen of the United States
- At least 18 years of age on or before February 27, 2024
- Resident of the State of Michigan

The **POLLS** of said election will be open at 7:00 a.m. and will remain open until 8:00 p.m. of said day of election for the purpose of deciding the following questions, namely;

Partisan Office to be Nominated:

President of the United States

Wright Township

Fire Protection Millage Proposal

Shall the previously voted increase in the tax rate limitation imposed under Article IX, Section 6 of the Michigan Constitution on general ad valorem taxes in Wright Township of 0.7846 mills (\$0.7846 per \$1,000 of taxable value), as reduced to 0.7625 mills (\$0.7625 per \$1,000 of taxable value) by the required millage rollbacks, be renewed and increased by 0.0221 mills (\$0.0221 per \$1,000 of taxable value) up to a total of 0.7846 mills (\$0.7846 per \$1,000 of taxable value), and shall Wright Township levy such millage annually for four (4) years, 2024 through 2027, inclusive, to provide funds for the purpose of purchasing and maintaining fire equipment and providing fire protection services within the Township?

If approved and levied, this millage would raise an estimated \$150,790.68 in the first year of the levy. All or a portion of the revenues from this millage will be disbursed to the Wright-Tallmadge Fire Department. As required by law, a portion of the total revenues from the tax levy will be captured by and disbursed to the Ottawa County Brownfield Redevelopment Authority.
